Regarding your letter Am.Dza/245-02/12/609 about phytosanitary requirement for potatoes and other imported plant, herewith we inform you that Indonesian Agricultural Quarantine Agency will be conducted Import Risk Analysis (IRAs) for determine level of protection.

Base on of IRAs result, we will submit you a detail phytosanitary requirements as import condition. Therefore, for purpose of IRAs process, we need any technical information for initiate of IRAs process of commodities which will be exported to Indonesia. The technical information we need can be found in attachment.

The phtosanitary requirement for Importation for sawn timber with bark, as follow:

The consignment should be accompanied by Phytosanitary Certificate from National Plant Protection Organization of Republic of Poland. The sawn timber should be free from Bursaphelenchus xylophilus (pine wood nematode), Pineus boerneri (pine wolly aphid), Heterebrostrychus aequalis (powder post

The consignment should be treated use methyl bromide fumigation or heat b.

treatment by registered provider treatment.

Methyl bromide fumigation use the dose rate, as follow are : C.

48 g/m³/24 hours for temperature more than 20°C; or

56 g/m3/24 hours for temperature 20 $^{\circ}$ C - 16 $^{\circ}$ C; or

 $64 \text{ g/m}^3/24$ hours for temperature 15 °C - 11 °C.

Heat treatment (kiln drying) should be applied for minimum temperature of wood core 74°C (165°F) with duration of treatment more than 4 hours.
